

In December the finance office received its first escrow property tax payments through Auto Agent. This software was free to the city, works with our current accounting & billing software. It allows us to import files of property tax payment files versus manual entering payments.

Cash in checking and certificates of deposit in the general fund total \$2,582,280. The Water Fund has operating funds, including savings and certificates of deposit totaling \$1,433,435. The Water/Wastewater construction funds account has a balance of \$2,321,591 customer deposits regular & savings in the amount of \$646,040. The gas fund has operating funds, including savings and certificates of deposit totaling \$4,482,648. The customer deposits in gas total \$711,931.





The City of Mount Pleasant now has an E-Bill Program.

This program will allow our water, wastewater, gas, and sanitation customers to have their monthly bill sent via email, replacing the monthly postcard you receive now.


- Check caulking and grout around sinks, showers, and tubs; clean grout or repair as needed.
- Clean and vacuum curtains, window blinds, and ceiling fans.
- Clean garbage disposal: Run with crushed ice to sharpen, then with baking soda and citrus peels.
- Check weather stripping and insulation.
- Regularly check your roof and gutters for ice dams and icicles.
- Test smoke detectors and carbon monoxide detectors.
